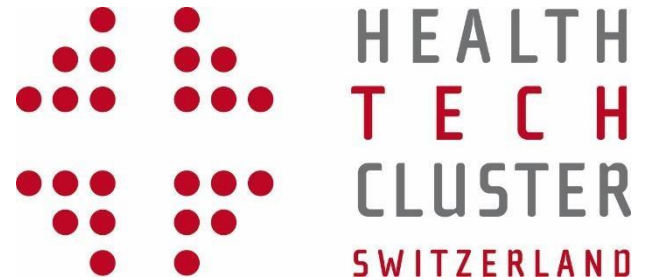

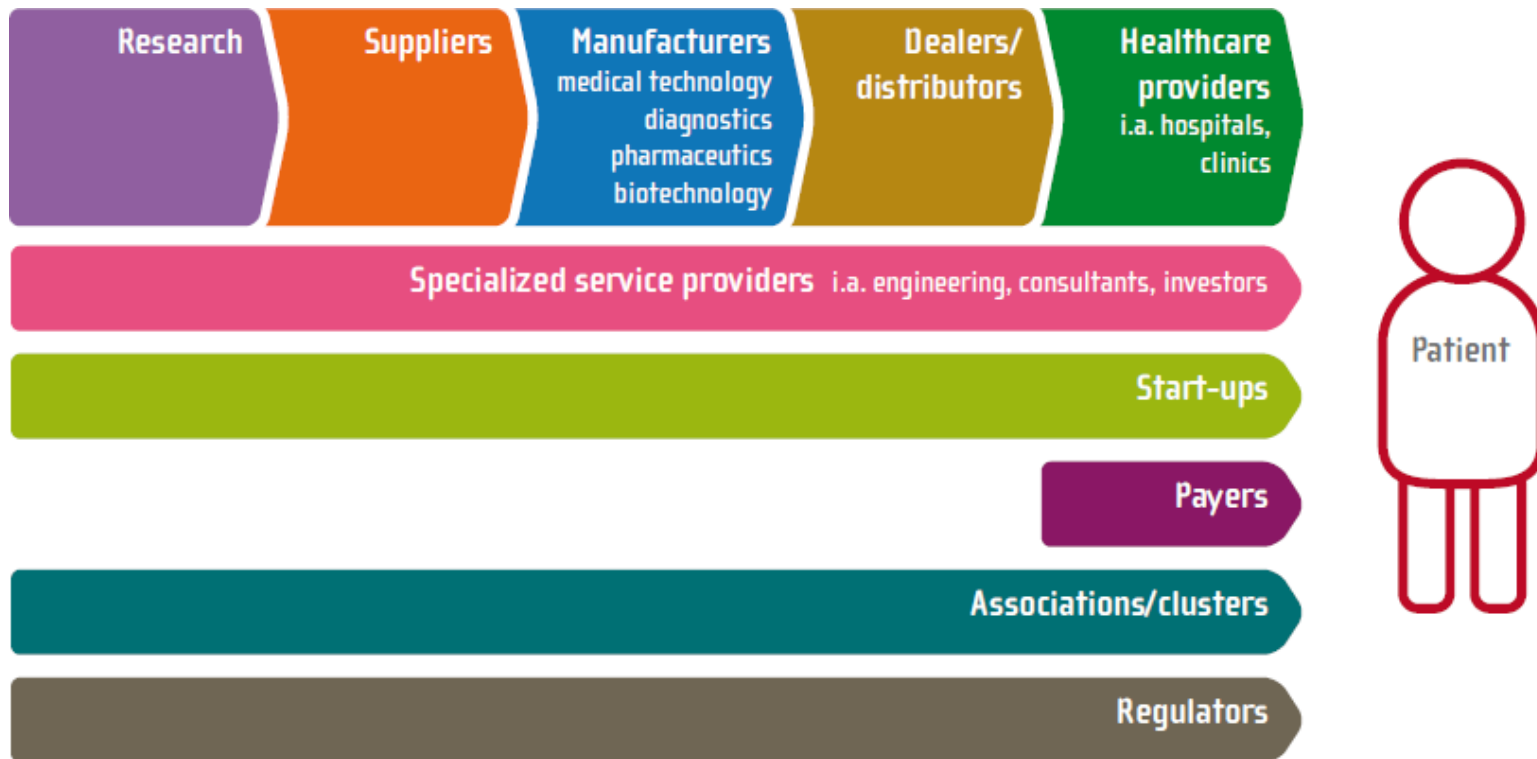

Corporate taxation

- **General**

- Profit tax can be offset against minimum tax (capital tax)
- Immediate depreciation

- **Incorporated companies**

- Profit tax in % of the profit before taxes: from 11.77 – 14.47 %
- Minimum tax (capital tax) in % of the taxable equity: 0.007 – 0.013 %

- **Research & development:** additional deduction 50 %

- **Patent box:** deduction on profit 90 %

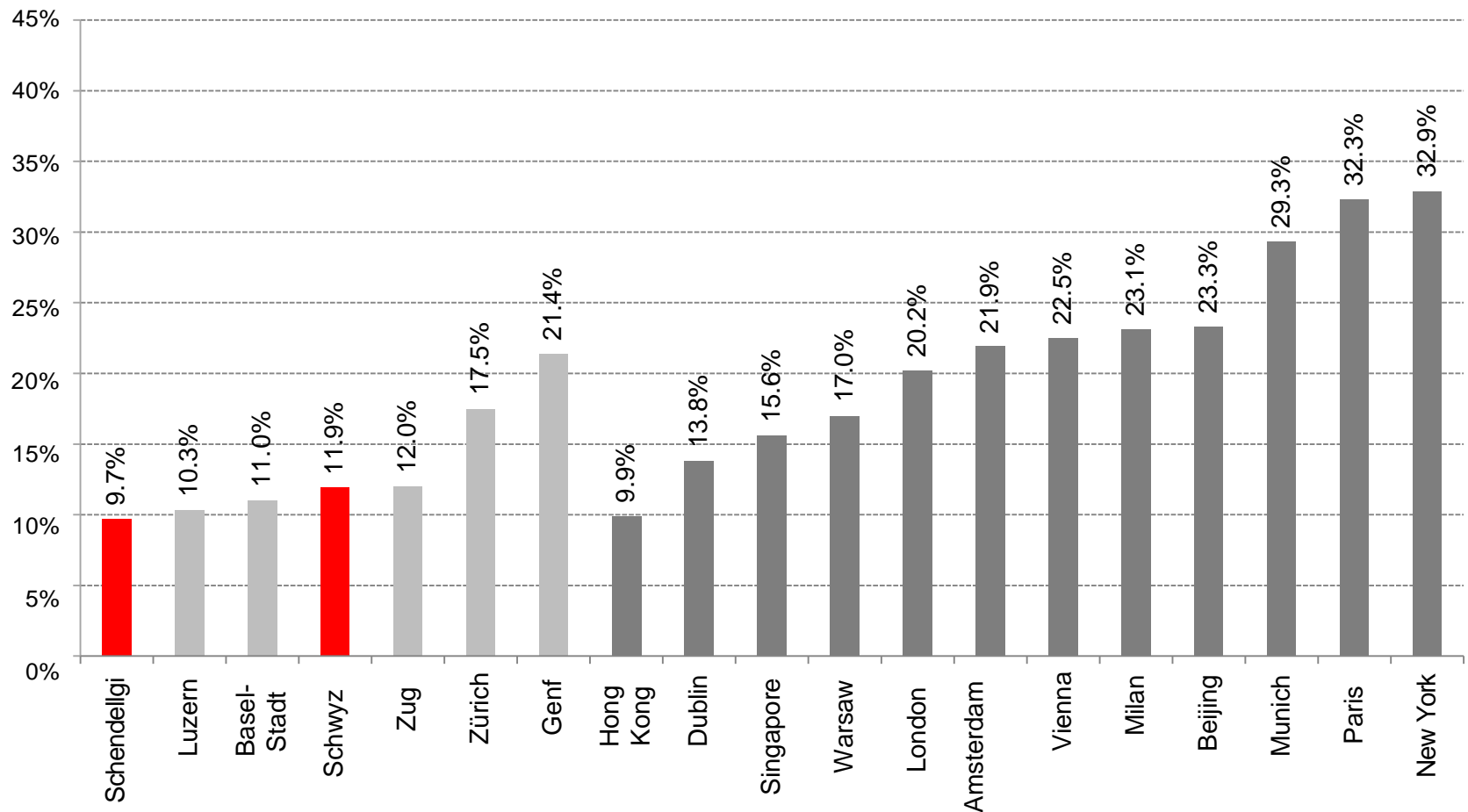
- **Deduction limit:** maximum deduction 70 %

- **Step-up**

- Old-law step-up: 5 years
- Special tax rate: 1 – 1.75 %, 5 years

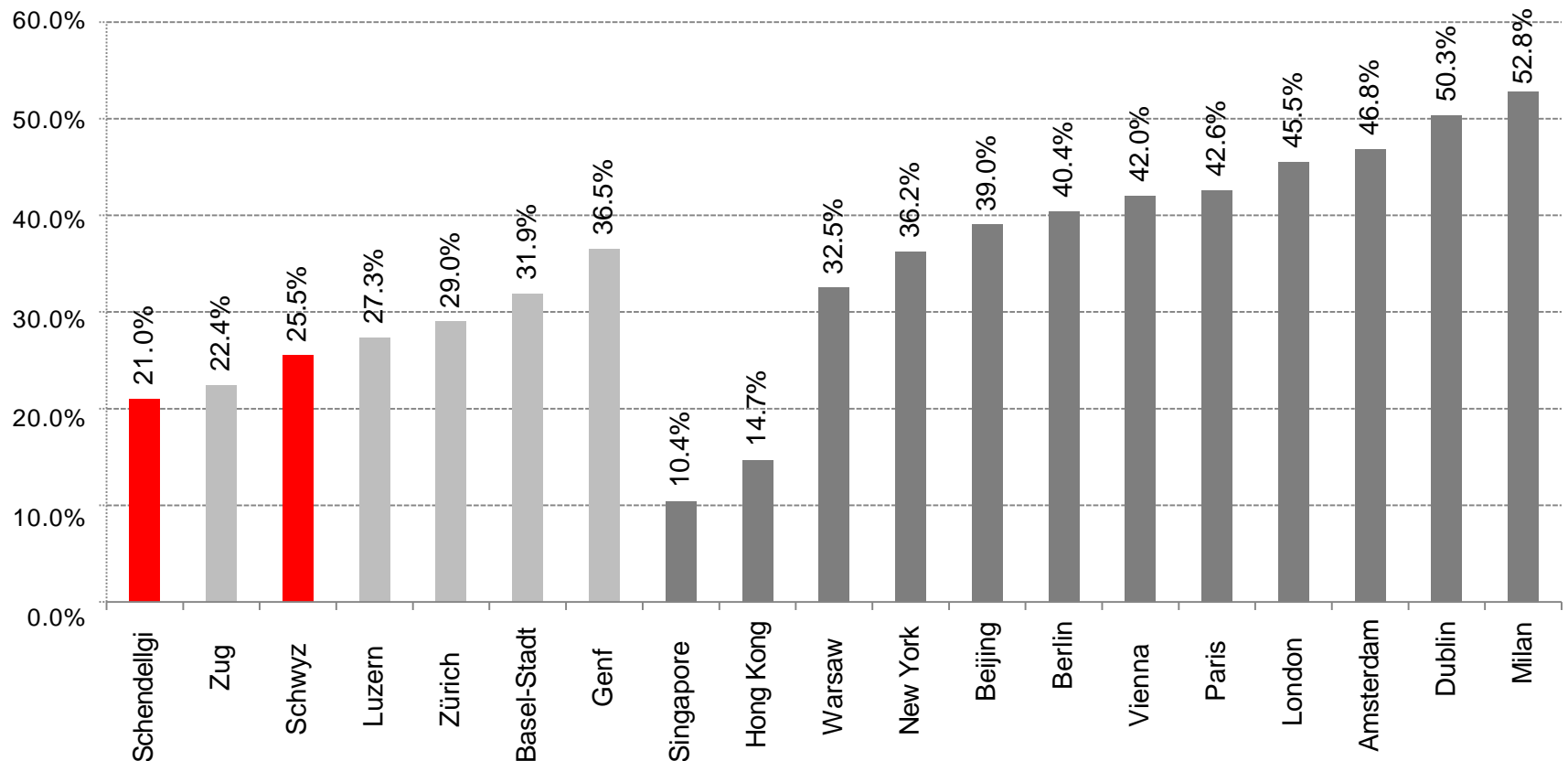
Effective average tax burden in % (capital + Schindellegi)

Tax burden on private individuals

- Taxable income of CHF 150,000 (EUR 130,400)* in Wollerau attracts CHF 19,700 (EUR 17,100)* in taxes (Single, municipal, district, cantonal and federal tax, without church tax)
- Tax on dividends (minimum holding 10 %):
 - Federal: 70 % taxable
 - Cantonal: 50 % taxable
- Capital tax (cantonal) 0.14 – 0.23 % (Single, municipal, district and cantonal tax, without church tax)
- No inheritance tax
- No gift tax

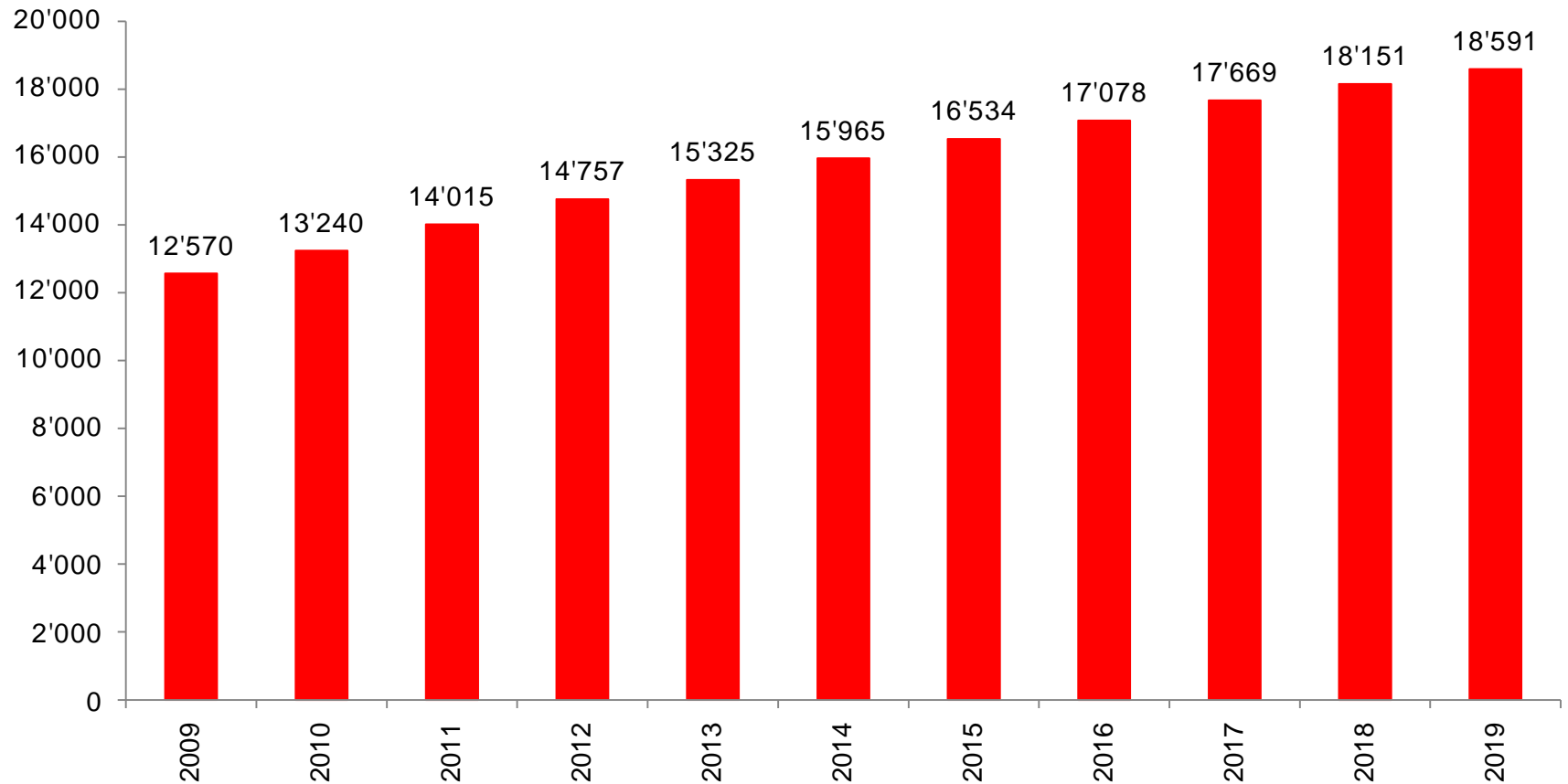
